Prior to her employment with RPF Environmental, Ms. Ham worked as a project technician for Stoney Ridge Environmental, Ms. Ham's duties included performing erosion control monitoring at construction sites, filling out wetland and shoreline permit applications for clients, and several different types of environmental field work, such as natural resource inventories and wetland delineations.
